**Abstract description (EN):**

Act on Equal Opportunities for Women and Men obliges local government communities to, within the framework of their competencies, promote and establish equal opportunities and take into consideration the gender equality perspective with regard to the adoption of measures and activities needed for the establishment of equal opportunities. Local government communities may appoint a co-ordinator for equal opportunities who shall take part in the preparation and implementation of the National programme for equal opportunities for women and men in the part which concerns local government communities, shall propose measures and activities in the field of the establishment of equal opportunities and shall have a consultative role in the formulation of solutions within the framework of an individual local community. When adopting development plans and other decisions, bodies of local government communities shall discuss proposed measures and activities submitted by co-ordinators for equal opportunities and give them appropriate consideration.
