ACT IMPLEMENTING THE
PRINCIPLE OF EQUAL
TREATMENT

Abstract description (EN):

This Act determines common bases and premises for ensuring the equal treatment of all persons in exercising their rights and duties and implementing human rights and fundamental freedoms. For the purpose referred to in the previous paragraph, this act determines the subjects that create conditions for the implementation of the principle of equal treatment, through measures within the framework of their competence, and raise awareness amongst discriminated persons and alleged offenders, as well as in society as a whole. This act further establishes the institutional conditions for the activities of the Advocate of the Principle of Equality, who provides assistance to discriminated persons through consideration of cases of alleged unequal treatment under the provisions of this act. This act also determines the common particularities which apply to the legal protection of discriminated persons in judicial and administrative proceedings, initiated on the grounds of violation of the ban on discrimination on the basis of personal circumstances, determined by law.

S tem zakonom se določajo skupni temelji in izhodišča za zagotavljanje enakega obravnavanja vsakogar pri uveljavljanju njegovih ali njenih pravic in obveznosti ter pri uresnicevanju človekovih pravic in temeljnih svoboščin. Za namen iz prejšnjega odstavka določa ta zakon subjekte, ki z ukrepi v okviru svojih pristojnosti ustvarjajo pogoje za uresnicevanje načela enakega obravnavanja ter skrbijo za osveščanje diskriminiranih oseb in domnevnih kršiteljev oziroma kršiteljic kot tudi družbe kot celote, ter vzpostavlja institucionalne pogoje za delovanje zagovornika oziroma zagovornice načela enakosti, ki z obravnavo primerov domnevnega neenakega obravnavanja po določbah tega zakona nudi pomoč diskriminiranim osebam. Ta zakon določa tudi skupne posebnosti, ki veljajo za pravno varstvo diskriminiranih oseb v sodnih in upravnih postopkih, sproženih zaradi z zakonom določene kršitve prepovedi diskriminacije na podlagi osebnih okoliščin.
