Strategic engagement for gender equality 2016-2019



increasing female labour-market participation and the equal economic independence of women and men



reducing the gender pay, earnings and pension gaps and thus fighting poverty among women



promoting equality between women and men in decisionmaking



combating gender-based violence and protecting and supporting victims



promoting gender equality and women's rights across the world





Forms of violence against women

Domestic violence, including intimate partner violence

Sexual violence, including rape and sexual assault

Sexual harassment and harassment based on sex

Stalking

Cyber violence, including cyber harassment, cyber stalking and online sexist hate speech

Sex trafficking

Harmful practices, e.g. female genital mutilation, forced marriage, so-called "honour crimes"




Figure 13a: Percentage of women experiencing sexual and/physical violence since the age of 15


Figure 13b: Percentage of women experiencing sexual harassment since the age of 15

33%

10% by partner & non-partner
12% by non-partner



45% have not been victims of sexual harassment

55% have been victims of sexual harassment: 18% in the work place 10% online

VIOLENCE AGAINST WOMEN: HEALTH IMPACT

Women exposed to intimate partner violence are ->

Mental Health





Sexual and Reproductive Health

16% more likely to have a low birth-weight baby

1.5 TIMES X

more likely to acquire HIV and 1.5 times more likely to contract syphilis infection, chlamydia or gonorrhoea

Death and Injury



of women who have experienced physical or sexual violence at the hands of a partner have experienced injuries as a result

38%

of all murders of women globally were reported as being committed by their intimate partners

Focused Actions to combat violence against women (2017)

- □ Funding to support national information, awareness-raising and education activities aimed at preventing and combating violence against women
- ☐ Funding for transnational projects by civil society organisations, local authorities, universities and other stakeholders
- European "umbrella" activities including Eurobarometer on gender-based violence, social media campaign, exchanges of good practice, Maltese Presidency conference on violence against women, mainstreaming in other policy areas

☐ Istanbul Convention

■ All member states have signed this Convention + ratification process ongoing



Double burden: Involving men



Legislation...

- Revised parental leave directive
- 10 days paid paternity leave
- 4 months for both parents, paid at sick leave level
- Flexible working arrangements
- Carer's leave



... but also policy pressure

- Monitoring the Barcelona targets
- Country-specific recommendations on female employment in 10 EU Member States
- Mutual learning & capacity building on e.g. dismissal protection pregnancy

... and financial support

- Use of the Structural Funds to develop childcare/ other care facilities
- Call for projects on 'closing gender gaps'





Beijng Platform for Action

Women and health

- women's access throughout life cycle to appropriate, affordable and high quality health care, information and related services
- -preventative programmes promoting women's health
- -gender sensitive initiatives to tackle sexual diseases and reproductive health issues
- -research and information on women's health
- -monitoring women's health

Violence against women

- -integrated measures to prevent and eliminate violence against women
- study of causes and consequences and effectiveness of preventative measures
- -elimininate trafficking of women
